# RE: REVISED BOARD PERFORMANCE EVALUATION TOOLS AND SCHEDULE - FY 2022

# a) Revised Board Evaluation Tools

Mwongozo; the Code of Governance for State Corporations, and government policy as communicated vide circular OP/CAB. 1/43/1 of 29th June, 2011 requires Board of Directors in State Corporations to carry out annual performance evaluation and file a report with the parent Ministry and the State Corporations Advisory Committee. The relevant evaluation tools which were released through the aforementioned circular, have been in use for over ten (10) years since their issue in 2011

Due to passage of time and on the basis of lessons learnt, the tools have been reviewed to incorporate some of the latest developments in corporate governance and address inherent noted weaknesses and gaps. The revised tools have addressed, among others, the following concerns;

- Redesigned the Tools to remove issues/items that are ambiguous; not within powers or control of the Board.
- ii. Reduced and rationalized the number of evaluated items especially in relation to evaluation of Corporate Board performance.
- iii. Sharpened the CEO's evaluation tool to include responsibilities on statutory reporting.
- iv. Included the evaluation tool for the Corporation Secretary which has hitherto been nonexistent.

In this regard, Commencing 1<sup>st</sup> July 2022, Boards of Directors will carry out annual performance evaluation using the revised evaluation tools (annexed herewith) and file a report with the parent Ministry and the State Corporations Advisory Committee. For ease of access, the State Corporations Advisory Committee has been asked to post the tools on their website www.scac.go.ke.

### b) Board Self Evaluation Schedule FY 2021/2022

As communicated vide Circular No. OP/CAB.9/1A dated 11<sup>th</sup> March, 2020, State Corporations are required to schedule annual Board Evaluation activity as part of their Almanac and notify the State Corporations Advisory Committee (SCAC) of the same by 31<sup>st</sup> July of each year. The circular further guided that Boards should undertake the evaluation exercise within the first four months of every financial year or as directed by SCAC.

Consequently, and in order to enable SCAC support the Board evaluations within the specified time frame; it has been found necessary to propose dates (attached herewith) when SCAC officers will be available to facilitate Boards undertake the exercise. In this regard, you are required to bring this information to the attention of your Board to consider and incorporate the proposed date in FY2022/2023 Board Almanac and submit the same to the Secretary, SCAC before 30<sup>th</sup>June, 2022.

In instances where a Board has compelling reason(s) for not aligning its almanac to the proposed date, the same should be communicated and a new date be agreed upon. However, any such rescheduling should be within  $1^{\rm st}$  July and  $30^{\rm th}$  September 2022.

The evaluation will be conducted through the Board Evaluation module of the State Corporations Information Management (SCIMM). You are therefore required to ensure that Board Members' data and particulars are updated in the System (SCIMM) by 15<sup>th</sup> June, 2022 and thereafter your Corporation Secretary should be updating and reporting promptly whenever changes occur in the Board membership.
