The Forum will focus on the theme: **Strengthening the Internal Audit Function as a Key Driver for the Implementation of the Zero Fault Audit Regime**. Indeed, the criticality of the internal audit function as an assurance framework on the management of risks and provision of independent and objective advice within State Departments, cannot be gainsaid.


